As we celebrated our 40th year of serving our community, we want to acknowledge that our success is made possible by our generous donors and community supporters.

In Fiscal Year 16-17 Family Support Center served 3,223 individuals with 69,343 hours of direct care. This was accomplished by 65 employees, both full and part-time. The agency also had the support and assistance of 13,028 volunteer hours of service given by 1,506 unduplicated volunteers. These hours were a 9% increase over the previous fiscal year. Family Support Center is pleased to report that 87¢ of every dollar raised goes directly to program support.

4b (Code:) (Expenses \$ **395,038** including grants of\$) (Revenue \$ **188,497**)

Counseling Services: Professional therapy for children, families, and individuals. 446 clients received over 4,327 hours of therapy. 268 individuals attended educational classes taught by clinical staff for a combined total of 890 staff hours. 58 sessions of support groups ran for 116 hours. No show rates were reduced by 6% from last year's numbers. 90% of clients in the Clinical Services department reported an increase in quality of life after using Family Support Center services.

LifeStart Village: Housing and self-sufficiency program for homeless single parents and their children. 234 individuals were served across all three phases of the program. Over 764 hours of case management and 1,118 hours of counseling were provided. 92% of single parents living at LifeStart Village Phase I increased their Self-Sufficiency score during the year, and 72% increased their income during the year.

One key volunteer project included the receipt of a \$10,000 donation and over 286 hours of service in one day from Windermere Commercial Real Estate to help update a building into our new Admin South Building. This building now houses a clinical staff member, our Adoption Respite Care staff, the In-home Parent Education Program staff, and space for classes and meetings. This project saved the agency close to \$100,000 in capital expense.

Individual Program Services for the year include:

Crisis Nurseries: 24/7 free short-term childcare for families in crisis situations and children at-risk of abuse or neglect. 1,457 children made 9,326 visits to the crisis nursery, including 858 overnight stays, 9,671 meals, and over 51,742 hours of care. These service totals also include 664 families experiencing homelessness, who were provided with both daytime and overnight

visits. The crisis nurseries provided a safe refuge for 71 children at risk for abuse or neglect and 68 children whose families were involved in domestic violence situations.
