Counseling Services: Professional therapy for children, families, and individuals. 120 clients received over 1,546 hours of therapy. We were able to serve 25% of our clients on a sliding fee scale which directly allows low income families without Medicaid to receive counseling. The counseling department staff feel lucky to be able to witness human beings reach their potential every day as they become the best versions of themselves.

LifeStart Village: Housing and self-sufficiency program for homeless single parents and their children. 180 individuals, including 67 adults and 113 children were served across all three phases of the program.
