One mother stated, " My son is not easy to get to talk with in sessions. My therapist has been amazing with him! She is so compassionate and fun, she gets him to open up and engage and really keep his needs at the center and focus of sessions."**

Seeing the effects of the pandemic in the families we serve, the FSC staff pulled together to meet their needs and rise together. We instituted a Parent Cafe, allowing the voices of parents to guide our work. We implemented a strategic plan, a new parenting-education curriculum, and expanded our services to Tooele County. We added new key positions to better serve clients and-because of these additions-more parents than ever have earned their GED at LifeStart Village and over 1,900 therapy sessions were provided! Through teamwork, and with the help of our community partners, the FSC ended the year in a fiscally sustainable position, able to continue serving the community for many more years to come.

Fiscal Year 2020/2021 was a wonderful year filled with both unprecedented challenges and incredible growth. All efforts supported the mission of strengthening families, protecting children, and preventing abuse. We are happy to report the following accomplishments:

?As a whole, the agency served 870 clients, including 452 households. This was accomplished by 31 employees, both full- and part-time.

**Crisis Nurseries:** The three crisis nurseries provided 3,816 child care visits and 16,520 hours of care. 74% of parents "strongly agreed" or
